

## AMENDMENT 3: REQUEST FOR PROPOSAL

### REFERENCE NUMBER: GMA/004/23: DELIVERY PARTNER FOR THE OPERATION, MAINTENANCE, UPGRADE, AND MODERNISATION OF THE GAUTRAIN RAPID RAIL LINK SYSTEM ("GAUTRAIN")

Any words and expressions that are capitalised, which are used in this invitation or advertisement and not specifically defined, shall bear the same meaning given to them in the Request for Proposal ("RFP") for the Project, unless the context requires otherwise.

In accordance with Treasury Regulation 16, the Gautrain Management Agency ("GMA") is seeking to appoint a suitable and experienced delivery partner to operate, maintain, upgrade and modernise the Gautrain over a fifteen (15) year period, commencing in March 2026 after the expiry of the current concession agreement.

<b>Invitation</b>	The GMA acting under the delegation of the MEC of Transport and Logistics hereby invites Bidders to submit Bid Responses for the selection of the Preferred Bidder who will contract with the Gauteng Provincial Government for the operation, maintenance, upgrade, and modernisation of the Gautrain.
